**Happy New Year and welcome to our first online edition of MSEA News. In an effort to communicate with you quickly and cost effectively, we are going digital with our newsletter. With this change there may be a few growing pains, but we believe it will be worth it.**



MSEA members voted overwhelmingly to ratify the economic agreement for the second two years of the current three-year agreement with the State of Michigan. Ninety-seven percent of member participants voted in favor of the agreement. The agreement provides across the board wage increases for all employees:

- 2% - effective 10/1/20
- 1% - effective first full pay period of 3/21
- 2% - effective 10/1/21
- 1% - effective first full pay period of 3/22

No changes to health care premium shares, co-pays or deductibles during the term of the agreement.

## **MSEA Member Wins - 2019**

### **Arbitrations**

LL18-018 - Conservation Officers awarded denied overtime while working Belle Isle State Park and Arbitrator found DNR violated contract in Articles 5 and 20 by not disclosing work rules and policies in writing with MSEA prior to implementation.  
 LL8-033 - Conservation Officers awarded single room occupancy after been forced to lodge with a roommate. DNR violated contract in Articles 13 and 43.  
 LL18-035 - DNR FFO awarded two days of overtime back pay. Arbitrator found the Department overstepped by not following proper disciplinary protocols and MSEA CBA Article 9 and 10.


